AN ACT

TO AMEND 2 CMC §5104, TO ESTABLISH A MANDATORY CATCH RECORDING AND REPORTING SYSTEM AND FOR OTHER PURPOSES.

The Bill was referred to the House Committee on Natural Resources.

THE BILL WAS PASSED BY THE HOUSE OF REPRESENTATIVES ON FIRST AND FINAL READING, APRIL 26, 2012; without amendments and wansmitted to the THE SENATE.

The Bill was referred to the Senate Committee on Resources, Economic Development and Programs. THE BILL WAS PASSED BY THE SENATE ON FIRST AND FINAL READING, OCTOBER 11, 2012; without amendments.

H. B. 17-282 WAS RETURNED TO THE HOUSE OF REPRESENTATIVES ON OCTOBER 15, 2012.

THE BILL WAS FINALLY PASSED ON APRIL 26, 2012.

AN ACT

TO AMEND 2 CMC § 5104, TO ESTADLISH A MANDATORY CATCH RECORDING AND REPORTING SYSTEM AND FOR OTHER PURPOSES.

Be it enacted by the Seventeenth Northern Marianas Commonwealth Legislature:

Section 1. <u>Findings and Purpose</u>. The Legislature finds that since the enactment of Public Law 2-51, the Division of Fish and Wildlife within the Department of Natural Resources assumed the responsibility for the protection of fish, game and endangered and threatened species exclusively within the CNMI.

Over the years, the Division of Fish and Wildlife has asked and received cooperation with various persons and business entities to provide data on all fish harvested for commercial and retail sale. Such information included types of fish harvested and their measurements such as weight and length.

| 19 | circumstances other than those to which it is held invalid shall not be affected thereby. |
| 20 | Section 4. Savings Clause. This Act and any repealer contained herein shall not be |
| 21 | construed as affecting any existing right acquired under contract or acquired under statutes |
